However, we cannot help but note that some companies, whether customers or not, are at times making deceptive use, or even misuse of our marks. These uses may take various forms:

- Deceptive declarations, which mislead a consumer, such as: “product manufactured with OK biobased compliant materials”, “developed in accordance with OK compost requirements”;
- Declaration of conformity with a TÜV AUSTRIA mark without the product in question having been duly certified. This declaration may take various forms (marketing documentation, website, ... );
- Use of an invalid certificate (expired or declared void);
- Changing the characteristics of a certified product without informing TÜV AUSTRIA of this;
- Altering a certificate issued for another product or another company;
- Using a mark or logo on a product without this being formally certified ;

- Wijziging van een certificaat dat is afgegeven voor een ander product of voor een andere firma.
- Aanbrengen van een merkteken of een logo op een product zonder dat dat formeel gecertificeerd is.

Als weltweiter Marktführer bei der Zertifizierung von Biokunststoffen ist TÜV AUSTRIA im Hinblick auf jegliche missbräuchliche Verwendung seiner Konformitätskennzeichnungen äußerst wachsam.

Die überwiegende Mehrzahl unserer Kunden hält sich strikt an die Regeln für die korrekte Verwendung von Marken und Logos, auf denen der Ruf von TÜV AUSTRIA und von seinen Zertifikaten basiert.

Dennoch müssen wir immer wieder feststellen, dass manche Kunden, ob wirklich Kunden oder nicht, unsere Marken zuweilen irreführend oder sogar missbräuchlich verwenden. Diese irreführenden oder missbräuchlichen Verwendungen können in unterschiedlichen Formen erfolgen:

- Irreführende Angaben, die einen Verbraucher in die Irre führen, wie zum Beispiel: „Produkt mit OK-biobasierten konformen Materialien hergestellt“, „entwickelt in Übereinstimmung mit OK-Kompost-Anforderungen“;
- Konformitätserklärung mit einem TÜV AUSTRIA Zeichen, ohne dass das betreffende Produkt ordnungsgemäß zertifiziert worden ist. Diese Erklärung kann in verschiedenen Formen erfolgen (Marketingunterlagen, Webseite, etc.);
- Verwendung eines ungültigen Zertifikats (abgelaufen oder für ungültig erklärt);
- Änderung der Charakteristika eines zertifizierten Produkts, ohne TÜV AUSTRIA darüber zu informieren;
